

## **SOMERSET CRICKET LEAGUE**Honorary Secretary's Report 2019

The Somerset Cricket League found a new sponsor in 2019 when Monmouth Scientific Ltd. became the 4<sup>th</sup> sponsor of the League since its inception in 1973. The SCL is most grateful to David Pomeroy, Chairman and founder of the Bridgwater based company for his decision to support local cricket. Incidentally, David is also Chairman of Middlezoy Cricket Club, so he knows what cricket means to the clubs and players in the County.

The Somerset Cricket League again lost several teams including Kilve, Barrington, a Peasedown team and East Huntspill 1<sup>st</sup> XIs during and prior to the playing season. Barrington went out of existence at league level, while Kilve and East Huntspill decided to concentrate their resources by fielding single teams in the WSCL. At the time of writing this report it looks as though the SCL will comprise 106 teams in 2020 unless there are further withdrawals during the close season. However, on the brighter side, Leigh on Mendip CC and Kilmington & Stourton CC have entered additional teams. Three new teams have joined the SCL for the 2020 season. Stoke St. Gregory from the WSCL; Beaminster 2<sup>nd</sup> XI from the Dorset County League and TICCR Curry Rivel.

Taunton St. Andrews 2<sup>nd</sup> XI and Staplegrove 1<sup>st</sup> XI will play in Tier 3 of WEPL in 2020. The former won the J C Bail Trophy for the winners of the Premier Division of the SCL. TSA had a comfortable 28-point margin over Staplegrove. Instead of the usual promotion/relegation of two teams, the SCL received three teams from Tier 3 of WEPL (Somerset Division) due to the anomalies in the make up in the WEPL divisions after promotion and relegation had taken place. The 'knock-on' effect created a problem in the SCL as 3 teams were also relegated from Divisions 1 & 2. However, the issue was resolved at Div. 3 level as that division was already depleted.

The Brian Stockhill Trophy for the winners of Division 2 was taken by Trull 1<sup>st</sup> XI with 570 points, a Massive 107-point margin over Long Sutton 1<sup>st</sup> XI. Lympsham & Belvedere 1<sup>st</sup> XI took the Bryan Lobb Memorial Trophy by winning Division 3 with a slender points margin of 8 over second placed Weston super Mare 2<sup>nd</sup> XI. At the end of the season, Castle Cary 2<sup>nd</sup> XI was just 3 points clear of Huntspill & District 1<sup>st</sup> XI, the closest win of the season as the East Somerset team took the Terry Mockridge Memorial Trophy. Taunton Deane 3<sup>rd</sup> XI with 488 points won the Shrubbery Hotel Trophy in Division 5 with a 10-point advantage over Wedmore 1<sup>st</sup> XI.

The Division 6s were the first of the regionalised divisions and the Southern version was won with a 45-point margin by Fitzhead Crusaders with 550 points over Spaxton in second place. In the North, Butleigh 2<sup>nd</sup> XI won with 535 points and this was achieved by creating a comfortable margin of 34 points over second placed Bridgwater Pointers.

Lympsham & Belvedere 2<sup>nd</sup> XI totalled 489 points in Division 7 North where the division comprised only 9 teams. Huntspill & District 2<sup>nd</sup> XI were in second place with 452 points. South Petherton 2<sup>nd</sup> XI won Division 7 South with 494 points and had a slender 8-point margin over second placed Broadway & Horton 2<sup>nd</sup> XI.

In Division 8 South, North Perrott 3<sup>rd</sup> XI, won the division with 569 points, while Kilmington & Stourton 2<sup>nd</sup> XI finished the season 15 points behind them. In the North, Lydford Sports 2<sup>nd</sup> XI and Wells 2<sup>nd</sup> XI both finished with 458 points and Lydford Sports was adjudged the winner on account of recording more wins during the season. In both division 8s, teams played some others in their division more than twice. This was due to a limited number of teams in both divisions (8 in the South and only 6 in the North). However, teams in both divisions had full fixture lists with 18 matches.

The Sunday Independent Cup, which is awarded for the highest points' aggregate of all 11 divisions was won by Trull 1<sup>st</sup> XI for the second year running. The Ladbrokes Trophy for the 'Club of the Year' was won by Lympsham & Belvedere CC, while the Don Crouch Trophy, which is awarded for sportsmanship based on the scores recorded by their opponents, was won by Huish & Langport 2<sup>nd</sup> XI. The Committee determines the Young Player of the Year and the best All Rounder. In 2019, the young player trophy was renamed "The Monmouth Scientific Cricket League – Young Player of the Year Trophy". It awarded this new trophy to James Hawksworth of Long Sutton CC and Kevin Curtis of Temple Cloud CC took the Glastonbury Mowers All Rounders Award.

The Team of the Month prizes were won by four different clubs and were distributed on appropriate times during the season. Monmouth Scientific Ltd. took over the provision of the prizes and gave tickets for SCCC 20/20 matches amongst other goodies! Temple Cloud 1<sup>st</sup> XI (May); Broadway & Horton 2<sup>nd</sup> XI (June); Trull 1<sup>st</sup> XI (July); North Perrott 2<sup>nd</sup> XI (August) were the recipients of the 2019 season Team of the Month prizes.

The individual performances for the season have been accurately catalogued in the various statistical pages on the ECB website and those interested in this aspect of the game should consult the website (https://somcl.play-cricket.com/) for this detailed information.

**play-cricket.com** continued to provide a huge range of cricket statistics, while also managing the registration and results systems. The SCL was fortunate in that John Squirrell continued to manage the website using his unique skills to meet the challenges offered by the ECB's play-cricket website.

The 'Rules Meeting' was again cancelled due to a lack of proposals – we must be getting something right!! The few proposals that had been submitted will be determined by ballot at the AGM.

Drawing up the fixtures list continues to be a difficult job. Matching home & aways coupled with ground unavailability on some Saturdays has made it a time-consuming task. Furthermore, the low numbers of teams in divisions 8N & 8S has required some imagination to give all 14 teams 18 fixtures! A problem in the WEPL pyramid regarding a Bristol club failing to initially meet the Clubmark conditions, held up my production of the WEPL fixtures for 2020. Fortunately, the issue was resolved before the deadline of October 31, so I could go ahead and produce tier 1 & 2 fixtures after the Management Board had agreed that Downend remain in the Premier Division. This has caused a 'knock on' delay in producing the SCL fixtures, but hopefully these will now be produced well before the AGM.

Properly qualified Club Welfare Officers has become a key issue in most sports organisations and cricket is no exception. Safeguarding and protecting children in sport has become a key responsibility for all clubs and we in cricket are very fortunate to have a team of experts based at Lords, Edgbaston and Loughborough University who are quick to respond to any concern.

Bad language, dissent aimed at the officials and opponents, misuse of social media sites, together with bad behaviour often witnessed by the spectators, have again raised concerns amongst the Committee. It met last season and held a disciplinary hearing on a rare occasion in recent years. In future, the Committee has resolved to take the strongest possible action against individuals and clubs that exhibit bad behaviour.

This year the League's Dinner and Presentation Evening was held for the first time at Wembdon Cricket Club. The Club did a magnificent job in hosting this event and we shall look forward to future years at this Bridgwater club for functions and meetings. This year the principal guest, Dom Bess was joined by Matt Counsell, SCB and Management Committee, in a 'question and answer' session before presenting the trophies to the various winning recipients.

I conclude my remarks with thanks to the members of the Management Committee for the contributions they make towards the successful and efficient running of the business of the Somerset Cricket League.
