- 1 RESULTS NOT PHONED or FAXED by DEADLINE AS SHOWN ON PRE-SEASON CIRCULAR**

FINE = £10.

- 2 RESULTS SHEETS NOT SENT IN ON TIME (ie. by 1st CLASS POST IMMEDIATELY AFTER MATCH).**

Does not apply to faxed results. (Rule 5k). FINE = £10

- 3 FAILURE TO LIST ALL PLAYERS ON TEAM SHEET, EVEN THOSE WHO DO NOT BAT (Rule 7 a). FINE = £10**

- 4 FAILURE TO LIST ALL PLAYERS WHO WERE UNDER 19 ON AUGUST 31ST 2005 (Rule 5k). FINE = £10**

- 5 FAILURE TO RETURN TEAM FIXTURES SHEET to RESULTS SECRETARY by APRIL 30th. FINE = £10**

- 6 FAILURE TO RETURN CLUB DETAILS SHEET to HON. SECRETARY by January 31st Further FINE = £10.**

- 7 CANCELLED MATCHES OTHER THAN WET WEATHER FINE = £20 minimum. (This applies to defaulting team only). Rule 5 (h) ii).**
